Visiting Regulations

1. BASIC PROVISION

1) The Visiting Regulations of the Ice Arena issues the municipality of Třebíč as the owner of the Ice Arena (hereinafter " Arena/premises").

2) The operator of the premises is SK Horácká Slavia Třebíč under a lease agreement.

3) The Visiting Regulations define a binding rules of conduct for all visitors to the premises.

4) The purpose of the Visiting Regulations is primarily to ensure the safety of persons and property protection.

5) Each person must be familiar with the Visiting Regulations before entering the premises and must comply with the requirements and rules of conduct.

6) The Visiting Regulations are binding even if the event organizer is not the owner or the operator.

7) The Visiting Regulations will be displayed permanently and visibly at the entrance to the premises.

2. ENTRANCE AND STAY IN THE PREMISES

1) Each person is allowed to enter and stay on the premises only for sporting and other events organized by SK Horácká Slavia Třebíč, during the operating hours. When the operator does not organize the event or the event takes place outside normal working hours, a person is allowed to enter the premises one hour before the event. At the end of the event, visitors are required to leave the premises immediately and orderly. Visitors have the right to occupy the seat indicated on the ticket for the event.

2) Every visitor to the request of the organizers, municipal police officers and the Czech Republic Police officers is always required to show a valid ticket or similar document.

3) Each person entering the premises agrees to a personal security check and a luggage inspection carried out by a designated organizer, municipal police officer or the Czech Republic Police officer. Refusal of the check is a reason for restriction of entry into the premises.

4) There is a strict smoking ban, which also applies to electronic cigarettes.

5) Visitors who are apparently under the influence of alcohol or other narcotic or psychotropic substances are forbidden. The organizers have the right to conduct an orientation breath test.

3. THE PREMISES VISITORS' CODE

1) Each person entering the premises is obligated to behave so that no harm is caused to oneself or other persons, and no damage is caused to the premises or its equipment. Each visitor is obliged to respect rules of good manners, to avoid any incitement to racial, religious or political intolerance. Any person whose behaviour is deemed unacceptable or anyone who does not comply with the regulations can be usher out from the premises without any admonition and any refunds.

2) Each person is obliged to comply with instructions of the organizer, police forces, fire brigades and rescue services.

3) Park bicycles, cars or any other vehicles only on designated parking spaces.

4. INTERDICTIONS

In the Ice Arena Třebíč, the visitors are banned from:

- a) bringing pyrotechnics, weapons of any kind as well as objects that can be used as a weapon;
- b) manipulating with open fire in any way;
- c) bringing alcohol, drugs, flammables, toxic and other dangerous substances;
- d) bringing unwieldy or bulky objects which may be limiting for other visitors of the premises. Disputed cases are ruled by an organizer;
- e) entering areas that are not intended for visitors;
- f) throwing any objects on the ice ring or in the visitors' area;
- g) destroying facilities and equipment;
- h) making any sound or visual records of ongoing sporting or other commercial events without a permission of the organizers;
- i) discarding garbage outside designated areas or polluting any areas of the Arena in another way;
- j) covering oneself face in a way that makes it difficult or impossible to identify the person;

k) relieving oneself physical needs outside the toilets and designated places.

5. ORGANIZING SERVICE

1) Supervision and surveillance for ensuring security of persons and property, as well as surveillance of compliance with relevant legal and other regulations, including the Visiting Regulations, appertain to manager of campus by the organizing service.

2) Organizers are visibly marked.

3) Happening in the auditorium area can be monitored using a camera system, also video record can be taken.

4) The organizer is competent to determine when the capacity of the stadium/arena is full and to not allow enter another person interested in entering.

6. RESPONSIBILITY FOR DAMAGES AND CONSEQUENCES OF VIOLATION OF THE VISITOR REGULATIONS

1) Every visitor enters and stays in the premises at one's own risk. The operator is liable only for health or property damage caused by wilful or grossly negligent behaviour of responsible or authorized persons. The operator is not responsible for the damage or theft of the private property of the visitors.

2) Visitor is required immediately notify injury or property damage to the premises administrator or by a member of the organizing service.

3) Persons who break the provisions of the Visiting Regulations in anyway can be reported from the area.

7. EFFECTUALITY

At the 29th meeting of the town council on December 19, 2016, the Council of the municipality of Třebíč decided on the issue of the Visiting Regulations for Sports Facilities by Resolution No. 71/29 / RM / 2016.

This Visitor rules becomes effective on 20.12.2016.
