Duties and responsibilities

The Junior Technical Officer (JTO) will work under the general supervision of the FAO Assistant Director-General/Regional Representative for Europe and Central Asia, and the technical guidance and supervision of the designated Officer. The specific tasks of the JTO will include:

- Contribute to and assist in the elaboration of sector reviews, appraisal and backstopping of programmes and projects, including review and formulation of FAO of Technical Cooperation Programme projects;

Minimum requirements

- Preferably two years of professional experience in the field of agricultural sector policy analysis, projects, programme planning and implementation in transition countries in the Europe and Central Asian region.
- Working knowledge (level C) of English, knowledge of Russian will be an asset.
- Demonstrated analytical research ability, as shown in written policy papers.
